17/19 MATTERS ARISING

- 1. Road Matters:
- a) Middle Road, Levenwick: There was nothing to report
- b) Scousburgh Hill: The Clerk confirmed that she had not received an acknowledgment from either the neither SIC nor SNH of her email regarding the Red Throated Divers at the site. Mr Harrop stated that he could confirm that SNH had received the Community Council's correspondence. Mr Harrop reported that it would appear the sub-contractors intend to continue with the demolition works as planned but that they have been asked to start with the internal works first to reduce any possible disturbance to the Red Throated Divers. Young Red Throated Divers normally fledge early August.
- **3. Scrap Vehicles:** There was nothing new to report. The Clerk will request an updated from the SIC
- **4. Service Bus/Bigton Feeder Service:** Mr Nickerson had met with Mr Mogridge and explained the position the Bigton Shop have been in since 2014 with regard to receiving shop goods via the Service Bus when the timings of the morning feeder service to Bigton were changed. Mr Nickerson had requested that either an additional feeder service be introduced at 1200 or the current service be moved back to its original time. Mr Mogridge had promised to forward Mr Nickerson a summary of the discussions they had had and email them on to Elaine Park, SIC, to see if anything can be done.

17/20 ADOPTION OF UPDATED COMMUNITY COUNCIL CONSTITUTION 2017

1. Letter from SIC ref. Community Council Constitution: Following on from the letter received last month from the SIC regarding a number of agreed changes which have taken place to the original Community Council Constitutions since they were last signed in 2001/2002, including changes made to by election procedures and to who can audit/verify accounts, the members unanimously approved the adoption of the updated Constitution for Dunrossness Community Council and it was duly signed by the Chairman

17/21 FINANCE AND GRANT APPLICATIONS

1. South Mainland Amateur Swimming Club – To assist with the costs of a member of the club travelling to, and competing in, the British Summer Swimming Championships held in Sheffield. Only the top 24 swimmers per age group, per event are invited to attend: It was agreed, on the motion of Mr Nickerson, seconded by Mr Harrop, to award the requested sum of £360.

- 2. CDF Project Fund: Mr Mainland confirmed that the Community Council's Application for additional funding through the CDF Project Fund to help with the costs of maintaining the KSB Awards at St. Ninian's and Westvoe Beaches had been successful. As part of this project, the Community Council will organise to have the St. Ninian's treasure site tidied up, with the permission of the landowner. Mr Nickerson reported that he had already been in contact with James Tait of Island Trails in regard to clearing nettles etc from the site and would pursue the matter further. It was also agreed that the Clerk would forward beach 'clean-up' dates to Gary Cape for insertion in the South Mainland Notes of The Shetland Times. Groups can volunteer to clean either of the above beaches on one of these dates and earn a little money for the group they represent.
- 3. William McDougall, deceased: The Community Council had received a letter from a Mr Mike McDougall of Kent. Mr McDougall's late father (William McDougall) had died earlier in the year and had bequeathed £250 to Dunrossness Community Council "in appreciation of the way my parents grave has been maintained, the sum of Two Hundred and Fifty Pounds (£250) to be used at their discretion on amenities within Dunrossness and I declare that the receipt of the clerk or other proper officer of the said Community Council shall be a good and sufficient discharge of my Trustees". Mr William McDougall had been born at Grutness, his father being Factor of the Bruce Estate. His mother had died in childbirth and he had been raised by his father at the Sumburgh House Hotel until his father's death in 1937 when he left Shetland to live with maiden aunts in Peebles. The members were delighted with this unexpected donation and agreed to put some thought over the summer to what would be a suitable avenue for the money.

Notification of Planning Applications: Mr Harrop informed the members that planning applications for the Dunrossness area are still not all being but under the heading of 'Dunrossness' on the SIC Planning website page which means it is difficult to find all relevant applications for the area when searching the page on line. It would appear that this also means notification of all local applications is not being forwarded to the Community Council. Mr McGregor offered to raise this with Cllr Smith who is on the SIC Planning Committee. It was also agreed that the Community Council will write to lain McDermott, SIC Planning, copied to the three South Mainland Councillors, regarding this matter.

17/23 FEEDBACK FROM EXTERNAL MEETINGS

- 1. Fair Isle Electrical Company Meeting: Mrs Mitchell reported that all funding for this project is now in place, although there are still some loose ends to tie up before works can begin. It is hoped that the project will be complete by September 2018 approximately.
- 2. Review of Support to Association of Shetland Community Councils: As planned, the ASCC had held a meeting of Community Council Chairs to prepare a collective response to the SIC with regard to the above. Mr Mainland had been unable to attend in person but Dunrossness Community Council's views on this matter had already been forwarded and Mr Mainland could now reported that 11 out of the 17 Community Councils who had responded on this matter had gone for the same option as Dunrossness Community Council being that, as the SIC will now meet the duties of the Community Council Liaison Officer (CCLO), the admin duties of the ASCC should also be carried out by the SIC in house.

- **4.** Transport Scotland letter ref. Ferries Procurement Policy Review: A Ferries Procurement Policy Review stakeholder event had taken place in Lerwick on 18 may 2017. As no one from Dunrossness Community Council had been able to attend the meeting, the letter invites the Community Council to write with any views which they might have on the policy review. The specific questions which were asked at the stakeholder event were:

17/25 ANY OTHER BUSINESS

1. Air Traffic Control Provision at Sumburgh Airport: Mr Nickerson raised the matter of Highlands & Islands Airports proposal that the provision of air traffic control at its airports could be replaced by a centrally controlled system. Mr Nickerson stated that he had serious reservations with this and he suggested that the Community Council should support Alistair Carmichael in his efforts to make sure the safety of those flying is the highest priority. Mr Nickerson reported that a Scoping Study has been commissioned to investigate all options and suggested that the Community Council should request a copy of this from HIAL's Managing Director Inglis Lyon. The press indicates that so far only HIAL staff and some politicians have been consulted on this proposal and Mr Nickerson was interested to know if HIAL's aviation consultancy would be engaging with the Community Council and seeking the views of the oil industry. As well as requesting a copy of the Scoping Study, it was agreed that the Community Council should write to the Chairman of the Sumburgh Airport Consultative Committee and ask that he ensures representatives from HIAL are present at the next meeting to consult with all parties on this matter.

- **2. Kirk Yard Headstones:** Mr Nickerson reported that he had been asked by a member of the public whose responsibility it is to maintain Headstones in the Kirk Yards. The members reported that it is the responsibility of the family of the deceased. However, if the Headstone is considered to be dangerous to the public, this would be deemed a health and safety issue and the SIC would intervene.
- **3. Fair Isle Nurse Provision:** Mrs Mitchell reported that Fair Isle have made a complaint to the Health Board regarding the lack of provision of relief nurses for the Isle. There should be 3 in place but last year there was only one. A review has been ongoing for a year now but has never been completed and it appears no effort is being made to fill the vacancies.
